### Please note the following in the context of all the above scholarships:

1. Please note the Scholarship will be applicable on 1<sup>st</sup> Year Tuition fee only.
2. MUCET (Mody University Common Entrance Test)/Interview /Any other All India test is mandatory to avail the scholarship wherever applicable.
3. To continue the scholarship, the student must maintain the CGPA of 8.0 & above every year without any backlog, failing which the scholarship for that academic year would be withdrawn. **(Except MBA- Annexure – A Attached)**
4. Grant of the scholarship will cease if any indiscipline matter is reported against the student.
5. In case the scholarship of any student is withdrawn due to non-meeting of the eligibility criteria, the same would be reinstated in the subsequent years depending upon meeting the eligibility criteria in (as mentioned in point no.3) subsequent years. The other terms and conditions of the scholarship would be applicable.
6. Students must submit all the required documents at the time of application, no document will be asked individually. The decision will be taken based on the submitted documents and no claim will be entertained afterwards.
7. Scholarship is not applicable on PhD / M.Tech. / Certification / Diploma Programs / MACS / Pharmacy programs.
8. The students need to submit fees before the last date of fees deposit (as notified by the University) to avail the scholarship. Students submitting their fees after the last date will not be entitled for any scholarship.
9. Rounding Off: If the last digit of qualifying percentage is equal or more than 5 decimals. The number will be round off to the next Larger Number Round off the number up to next No.
