28. RE-EVALUATION/ RECHECKING OF PAPERS:

The University shall maintain transparency to the maximum extent feasible in the evaluation system, consequently students shall be granted permission for re-evaluation/re checking of their answer books of End Term papers only.

1. A candidate can apply for revaluation within seven days from the time of publication of the results in the specified application form by paying the prescribed fee in person/ RTGS/ NEFT.
2. A candidate can apply for revaluation for a maximum of three theory courses only.
3. After revaluation, if the marks secured by a candidate in the second valuation deviates from the first valuation by 10 or more marks, the script will be referred to a third valuation and the average of the three will be treated as the final marks secured by the candidate. Otherwise, higher marks of the first two marks secured by the candidates will be taken into account.
4. Any change in revaluation resulting in a higher grade will be declared and incorporated in the result accordingly. Otherwise it will be declared as "No Change".

5. There shall be no re-evaluation in the following marks/assessment:-

- (i) Lab / Practical examinations, tutorials
- (ii) Viva-Voce,
- (iv) Project Report evaluation,
- (iii) Thesis/Dissertation evaluation
- (iv) Assignments, Seminar, Quizzes etc.

However, in the exceptional circumstances, the grade/paper of a candidate may be scrutinized by the Dean concerned.
