Special category Fee waiver for the Academic Year 2025-2026

A) Alumni Fee Waiver Policy to Promote Higher Education: -

The students of Mody University/Mody School who seek admission to Mody University after qualifying for a degree/diploma/10+2 will be awarded an additional 10% scholarship on the tuition fee of 1^{st} year apart from the scholarship earned through merit criteria.

B) Sibling Fee waiver:

Mody University offers an additional 10 % waiver on the tuition fee of 1st year to one of the siblings studying at Mody University. The fee waiver will be allowed to continue even after the passing out of one sibling.

C) Fee waiver to students of Shekhawati (Sikar, Churu, Jhunjhunu District) domicile:

Mody University offers a 10% fee waiver on tuition fees for the entire duration of the course for students belonging to the Shekhawati region.

D) Fee waiver for EWS/SC/ST/PH or any other covered under Govt. Reserved Category

Mody University offers a 10% fee waiver on tuition fees for the entire duration of the course for students belonging to the EWS/SC/ST /PH category.

E) Fee waiver under Armed Forces Educational Welfare Scheme for Wards of Defense and Police Personnel's.

As a gesture of appreciation and salutation to our Defense Forces, who are always there to protect our borders and our lives, Mody University has devised a reservation cum Fee Waiver Scheme for the wards of Defense Personnel. This scheme is also a part of our social responsibility towards special sections of our society extended to wards of All Defense Personnel serving and retired. The fee waiver will continue for the entire course duration.

- Fee waiver equivalent to 50% of the yearly tuition fee for the Martyrs (wards & widows).
- Fee waiver equivalent to 35% of the yearly tuition fee for the wards of serving and retired defense personnel.
- Fee waiver is equivalent to 25% of the yearly tuition fee for the wards of serving and retired Police personnel.

Criteria for Continuation of Scholarships:

- For continuation of merit scholarships: It is mandatory that the students admitted under all the merit-based scholarship schemes must maintain a minimum of 8.0 CGPA in regular year exams in first chance with No backlog, No Disciplinary action, and 75 % Attendance failing which the scholarship shall be discontinued.
- Scholarship scheme swapping is not allowed.
- The student can't avail of multiple scholarships (Except Special Category Fee listed above in points A & B only).
- If a student is eligible for multiple scholarships, in that case, the student will be entitled to choose the best scholarship offered.
- If any student is entitled to both merit/special scholarships, she has to fulfill all the necessary criteria to get the benefit of both scholarships. If any student fails to maintain the eligibility criteria for a merit scholarship the next year, in that case, special scholarship will only be continued.
- For renewal of special scholarships, it is mandatory that the students admitted under all scholarship schemes (except EWS/SC/ST/PH) have No backlog, No Disciplinary action and 75 % Attendance.
- **Note:** If the scholarship is discontinued in one year due to not maintaining the mandatory requirements and in the subsequent year if the student maintains the minimum mandatory criteria, The student can apply for the scholarship again; however, in that case, the student would be eligible for only 50 percent of the earlier sanctioned scholarship in the subsequent year of study.



<u>Candidates who meet any of the following criteria are eligible for a 50% concession in Ph.D.</u> tuition fees:

- Qualified NET/JRF (for all disciplines), GATE (with ≥ 90th percentile), SLET, GRE (with ≥ 90th percentile), CAT (with ≥ 90th percentile), GMAT, CMAT, CEED, or other equivalent national-level examinations to join as a <u>full-time Ph.D. student</u>.
- Secured government-recognized fellowships such as DST-INSPIRE, Women Scientists Scheme (WOS), SVSGC Fellowship, JRFET Fellowship, ICAR, DBT, DST-WISE, UGC- (MANF, NFSC, NFOBC), or others granted specifically to pursue a <u>Ph.D. program as full-time</u> <u>students.</u>
- Employed as scientists in institutions of national importance, such as DRDO, CSIR, BARC, TIFR, or other national laboratories and central research institutes.
- Awarded Gold Medals or have topped their postgraduate or undergraduate programs at any UGC recognized university.

Eligibility for 25% Tuition Fee Concession

Candidates who meet any of the following criteria are eligible for a 25% concession in Ph.D. tuition fees:

- Teachers currently serving in government colleges or universities in a permanent capacity (Subject to submission of proper documents).
- Scientists/Researchers who are working in the private research industry.

Important Note:

- If a candidate has qualified for any other national-level examination or fellowship not explicitly listed above, they may still be considered eligible for the concession, subject to approval of the Competent Authority and fulfilling requirement to pursue PhD program.
- These tuition fee concessions are applicable for a maximum of three years from the date of admission.
- The University reserves the right to revise or withdraw the concession policy at any time during study. Revised terms, if any, shall be applicable as and when officially notified.
- **Criteria for Continuation of Scholarships**: For continuation of merit scholarships, It is mandatory that the students admitted under Merit Based scholarship schemes must maintain a minimum of 8.0 CGPA in regular year exams in first chance with, No Disciplinary action, and 75 % Attendance failing which the scholarship shall be discontinued .The scholarship continuation will be based on recommendation of the Guide / Student Advisory council.
