

# SCHOLARSHIP SCHEMES FOR THE ACADEMIC YEAR 2026-2027

## SCHOLARSHIPS FOR UG STUDENTS

Category	Description
A	Academic Merit (12th marks)
B	National Level Entrance Exams
C	Special Category Fee Waivers
D	Defence / Police Personnel
E	Alumni of Mody School or Mody University seeking to pursue further studies at Mody University of Science & Technology

**Note: Validity of Scholarship:** Scholarships shall be sanctioned only once at the time of admission and shall not be carried forward or renewed in subsequent academic years.

### A) ACADEMIC MERIT

The candidate must have studied and passed the Class XII examination or its equivalent from a recognized board. Candidates who have completed Diploma in Pharmacy or Diploma (Polytechnic, 10+3) from a recognized institution are also eligible. The candidate must have passed the Class XII examination from any board in India or from any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU). This scholarship is also applicable to candidates holding a Diploma in Pharmacy or Diploma (Polytechnic, 10+3) from a recognized institution.

**Note:** For the purpose of awarding Academic Merit Scholarships, the percentage of marks shall be calculated based on the aggregate of the best three core subjects relevant to the chosen program and one language subject, as prescribed for that program.

The selection of core subjects will strictly follow the program-specific eligibility criteria (e.g., PCM or PCB).

### Illustrative Example:

If a candidate has obtained the following marks in Class XII:

Physics: 78

Biology: 80

Chemistry: 88

Language (English): 72

Mathematics: 60

Painting: 90

The calculation of marks for scholarship consideration will be as follows:

- B.Tech (CSE) – PCM + Language → **Physics (78) + Chemistry (88) + Mathematics (60) + Language (72)**
- B.Sc. – PCB + Language → **Physics (78) + Chemistry (88) + Biology (80) + Language (72)**
- BBA / BA / BA LL.B. – Best three relevant subjects + Language → **Physics (78) + Chemistry (88) + Biology (80) + Language (72)**

**C) SPECIAL CATEGORY FEE WAIVER FOR THE ACADEMIC YEAR 2026-2027**

**C.1) Alumni Ward / Sibling Scholarship**

10% scholarship on Academic fee for wards of alumni or siblings of alumni or sibling of currently enrolled students of Mody School or Mody University for 1st year only.

**C.2) Fee waiver to students of Shekhawati (Sikar, Churu, Jhunjhunu District) domicile:**

Mody University offers a 10% fee waiver on Academic fees for 1st year only of the course for students belonging to the Shekhawati region.

**C.3) Fee waiver for EWS/SC/ST/PH or any other covered under Govt. Reserved Category**

Mody University offers a 10% fee waiver on Academic fees for 1st year only of the course for students belonging to the EWS/SC/ST /PH category.

**C.4) Special Scholarship for Residents of Salasar, Khatu Village, and Jeenmata Village**

Mody University offers a 10% scholarship on the Academic fee to students residing in Salasar, Khatu, or Jeen Mata for 1st year only (with a domicile certificate of Salasar, Khatu and Jeen Mata).

**D) Fee waiver under Armed Forces Educational Welfare Scheme for Wards of Defense and Police Personnel's.**

**Scholarships for wards of Defence, Paramilitary and Police Personnel**

Mody University has introduced a scholarship for the wards of Defence, Paramilitary and Police personnel.

The fee waiver is applicable on the **1<sup>st</sup> year Academic fee.**

- **50%** scholarships of the Academic fee for wards of Martyrs, died in service – attributable, disabled in action, disabled in service – attributable, gallantry awardees of Defence, Paramilitary and Police personnel.
- **35%** scholarships of the Academic fee for wards of serving or ex-servicemen of Defence, Paramilitary and Police personnel.

**E) Add-On Benefit to the Alumni of Mody School or Mody University Seeking to Pursue Further Studies at Mody University of Science & Technology**

Alumni of Mody School or Mody University who wish to pursue further studies at Mody University shall be eligible for an additional scholarship of 20% on the academic fee, over and above the scholarship awarded under Category A or B, as an alumni benefit, subject to the fulfillment of prescribed admission eligibility criteria and institutional norms. In cases where the alumni do not qualify under Category A or B, a scholarship of 20% on the academic fee shall still be awarded. This fee will be applicable on the **1<sup>st</sup> year Academic fee.**

**Note:**

1. **Single Scholarship Rule:** Only one scholarship shall be awarded to a student from Category A, B, C, or D, whichever is most beneficial to the student.
2. **Validity of Scholarship:** Scholarships shall be sanctioned only once at the time of admission and shall not be carried forward or renewed in subsequent academic years.
3. **Maximum Scholarship Limit:** Under no circumstances shall the total cumulative scholarship and/or fee waiver exceed 100% of the academic fee.
4. **Mode of Disbursement:** The approved scholarship amount shall be disbursed during the academic fee for first year.
5. **CGPA Calculation:** Conversion of CGPA to percentage, wherever applicable, shall be carried out strictly as per the official equivalence formula certified by the concerned College/University.
6. **Exclusion from Scholarship:** Scholarships shall not be applicable to candidates seeking admission through transfer, lateral entry, or direct admission to the second year under any program, **other than LEET and Diploma (Polytechnic, 10+3) or Diploma (Pharmacy).**
7. **Admission and Scholarship Award Process:** Admission to Mody University of Science & Technology shall be based on the candidate's performance in the prescribed written examination (if not appeared in any national level examination) and interview. Scholarships shall be awarded only after completion of the admission process, verification of eligibility, submission of all required documents, and successful clearance of the written examination (if not appeared in any national level examination) and interview.

### C) SPECIAL CATEGORY FEE WAIVER FOR THE ACADEMIC YEAR 2026-2027

#### C.1) Alumni Ward / Sibling Scholarship

10% scholarship on Academic fee for wards of alumni or siblings of alumni or sibling of currently enrolled students of Mody School or Mody University for 1st year only.

#### C.2) Fee waiver to students of Shekhawati (Sikar, Churu, Jhunjhunu District) domicile:

Mody University offers a 10% fee waiver on Academic fees for 1st year only of the course for students belonging to the Shekhawati region.

### **C.3) Fee waiver for EWS/SC/ST/PH or any other covered under Govt. Reserved Category**

Mody University offers a 10% fee waiver on Academic fees for 1st year only of the course for students belonging to the EWS/SC/ST /PH category.

### **C.4) Special Scholarship for Residents of Salasar, Khatu Village, and Jeenmata Village**

Mody University offers a 10% scholarship on the Academic fee to students residing in Salasar, Khatu, or Jeen Mata for 1st year only (with a domicile certificate of Salasar, Khatu and Jeen Mata).

### **D) Fee waiver under Armed Forces Educational Welfare Scheme for Wards of Defense and Police Personnel's.**

#### **Scholarships for wards of Defence, Paramilitary and Police Personnel**

Mody University has introduced a scholarship for the wards of Defence, Paramilitary and Police personnel.

The fee waiver is applicable on the **1<sup>st</sup> year Academic fee.**

- **50%** scholarships of the Academic fee for wards of Martyrs, died in service – attributable, disabled in action, disabled in service – attributable, gallantry awardees of Defence, Paramilitary and Police personnel.
- **35%** scholarships of the Academic fee for wards of serving or ex-servicemen of Defence, Paramilitary and Police personnel.

### **E) Add-On Benefit to the Alumni of Mody School or Mody University Seeking to Pursue Further Studies at Mody University of Science & Technology**

Alumni of Mody School or Mody University who wish to pursue further studies at Mody University shall be eligible for an additional scholarship of 20% on the academic fee, over and above the scholarship awarded under Category A or B, as an alumni benefit, subject to the fulfillment of prescribed admission eligibility criteria and institutional norms. In cases where the alumni do not qualify under Category A or B, a scholarship of 20% on the academic fee shall still be awarded. This fee will be applicable on the **1<sup>st</sup> year Academic fee.**

#### **Note:**

1. **Single Scholarship Rule:** Only one scholarship shall be awarded to a student from Category A, B, C, or D, whichever is most beneficial to the student.
2. **Validity of Scholarship:** Scholarships shall be sanctioned only once at the time of admission and shall not be carried forward or renewed in subsequent academic years.
3. **Maximum Scholarship Limit:** Under no circumstances shall the total cumulative scholarship and/or fee waiver exceed 100% of the academic fee.
4. **Mode of Disbursement:** The approved scholarship amount shall be disbursed during the academic fee for first year.
5. **CGPA Calculation:** Conversion of CGPA to percentage, wherever applicable, shall be carried out strictly as per the official equivalence formula certified by the concerned College/University.
6. **Exclusion from Scholarship:** Scholarships are **not applicable** for candidates seeking admission through transfer, lateral entry, or direct admission to the second year under any program.
7. **Admission and Scholarship Award Process:** Admission to Mody University of Science & Technology shall be based on the candidate's performance in the prescribed written examination (if not appeared in any national level examination) and interview. Scholarships shall be awarded only after completion of the admission process, verification of eligibility, submission of all required documents, and successful clearance of the written examination (if not appeared in any national level examination) and interview.

## ACADEMIC PERFORMANCE SCHOLARSHIP FOR BOTH PG/UG PROGRAMS

The scholarship awarded after the first year shall be independent of any scholarship availed by the student at the time of admission. Eligible students may be considered for this scholarship based on their academic performance in the preceding academic year, subject to fulfillment of the criteria mentioned below.

Eligibility criteria for the scholarship after the first year, the student must:

- Have no back paper(s) in the preceding year.
- No disciplinary action against the student.

Fulfil the CGPA criteria as specified below.

CGPA Obtained	Scholarship Percentage
9.5 & Above	35% of Academic Fee of the II/III/IV/V year
9 & Above	25% of Academic Fee of the II/III/IV/V year
8.5 & Above	20% of Academic Fee of the II/III/IV/V year

### Additional Provisions

- **Applicability of Scheme:** This provision shall be applicable to students who have been granted scholarships under Category A, B, C, D or E.
- **Consideration of Previously Ineligible Students (at the time of admission):** Students who were granted any scholarship or not granted any scholarship at the time of admission due to ineligibility may also be considered for this scholarship, provided they subsequently fulfil the prescribed eligibility criteria.
- **Verification and Approval:** The scholarship amount shall be verified and approved by the Registrar Mody University of Science & Technology.
- **Adjustment of Scholarship Amount:** Upon approval by the Registrar, the sanctioned scholarship amount shall be adjusted against the academic fee of the 4th, 6th, and 8th semesters, as applicable.

#### Important Note

- **Single Scholarship Rule:** Only one scholarship shall be awarded to a candidate from Categories A, B, C, D, E, F, or G, whichever is most beneficial.
- **Other National-Level Qualifications:** Candidates who have qualified in any other national-level examination or fellowship not explicitly listed may also be considered for a scholarship, subject to approval by the Competent Authority and fulfilment of eligibility requirements for pursuing the Ph.D.
- **Duration of Concession:** Academic fee concessions shall be applicable for a maximum period of three years from the date of admission, subject to annual review and compliance with continuation criteria.
- **Criteria for Continuation:** Continuation of merit-based scholarships is subject to the student:
  - Maintaining a minimum CGPA of 8.0 in the course work (first attempt),
  - No disciplinary action against the student.
  - Continuation shall be based on the recommendation of Student Research Committee (SRC).
