Subject: Reconstitution of Standing Disciplinary Committee

The **Standing Disciplinary Committee of Mody University of Science and Technology (MUST)** is hereby reconstituted to deal with matters relating to **student indiscipline, misconduct, misbehaviour, and other disciplinary issues** at the University.

The Committee shall have the following functions and responsibilities:

1. **To maintain discipline, decorum, and academic integrity** within the University campus.
2. **To create awareness among students regarding the University's Code of Conduct** and to take appropriate preventive measures against incidents of indiscipline and misconduct on the campus.
3. **To promote and maintain a healthy, safe, and conducive academic environment** by ensuring the proper implementation of disciplinary procedures and actions.
4. **To inquire into and investigate disciplinary cases** falling within its purview and provide the concerned student/person a reasonable opportunity to present his/her case before the Committee.
5. **To examine and assess the facts and circumstances of each disciplinary case and recommend appropriate action, wherever necessary, in accordance with the rules, regulations, policies, and guidelines of the University.**
6. **To take such other measures as may be necessary for maintaining discipline and decorum** at the University campus, as entrusted by the Competent Authority from time to time.
